1. Each exhibitor will be given a 10x10 space at the EVENT SITE. Food trucks are responsible for providing applicable food permits and licenses as well as abide by food handling and health inspector guidelines.
2. Each exhibitor is responsible for providing their own table(s), chairs, and tent if needed.
3. Exhibitors must be set up by 6:00 AM, and must have their area torn down/cleaned up by 12:00PM.
4. No refunds will be given to exhibitors who fail to occupy their space.
5. Exhibitor may not sublet their space unless given prior approval.
6. Exhibitors agree to be open and staffed during all event hours (7:00 AM to 11:00 AM).
7. Exhibitors are responsible for their space and property as well as the setup/tear down of their space.
8. Exhibitors must promote within their designated space and stay clear of walkways and interference of other exhibitors or the start/finish line.
